### **Certificate of Registration of Haj Group Organiser for Haj-2024**

This is to certify that M/s **Superb Enterprises Private Limited** Address **2nd Floor, Nehru Houser, 4 Bahadur Shah Zafar Marg, ITO, District - CENTRAL DELHI, State - DELHI, Pincode - 110002** is duly registered with Ministry of Minority Affairs (MoMA) as Haj Group Organiser (HGO) for Haj 2024 (1445-H) and has been allotted total quota of **50** pilgrims , after determining eligibility and draw of lots.

2. **M/s Superb Enterprises Private Limited** Address **2nd Floor, Nehru Houser, 4 Bahadur Shah Zafar Marg, ITO** (Name of the responsible Person: **Mr.Syed Tufail Ahmad, Shaquib Raza Ansari** ) (hereinafter referred as HGO) has agreed to abide and be bound by all the terms and conditions mentioned by the Indian and Saudi authorities which are available on the website of the Ministry at <https://www.minorityaffairs.gov.in> and <https://www.haj.gov.in> and on the web site of Haj Committee of India at <https://www.hajcommittee.gov.in>.

3. The HGO shall abide by the Policy for Haj Group Organisers for Haj 2024 circulated vide circular No. 15/28/2022-Haj-MoMA dated 22.12.2023 and will be held directly responsible for non-compliance of any of the terms and conditions of registration with MoMA at any stage. The Ministry reserves the right to suspend/cancel the registration in case of non-compliance of any of the terms and conditions including black listing the company and its proprietor/partner/director(s).

4. Special attention of the HGO is invited to the provisions of Circular No. 15/28/2022-Haj-MoMA dated 22.12.2023 and it is hereby conveyed that if any discrepancy is found in the documents submitted by the HGO, at any stage, and subsequently as well, and/or if any complaint is received against the HGO regarding misleading documents/submission for Haj, 2024/tax evasion, and found to be actionable, appropriate penal action will be taken against the concerned HGO, including forfeiture of security deposit and debarment. Further, it is also informed that complaints received from pilgrims/intending pilgrims against HGOs shall be got verified and will also be dealt with very strictly by the Ministry.

5. Further, the HGOs are required to ensure compliance of instructions issued by the Government of Saudi Arabia, from time to time, for international pilgrims including the following :-

(a) The pilgrims must have completed the basic immunizations by vaccines approved by the Ministry of Health, Govt of KSA.

(b) The pilgrims shall comply with the CoVID-19 protocol, as applicable, as per the norms of Kingdom of Saudi Arabia. The HGO shall be required to obtain insurance for Haj pilgrims including Treatment costs for infection with Coronavirus (Covid-19) for the pilgrims during their stay in the KSA for Haj.

(c) Compliance with the age restrictions as may be imposed by KSA for pilgrims.

(d) Any other instructions as issued by KSA or Ministry of Minority Affairs from time to time.

6. All HGOs registered by the Ministry shall ensure that at least 50% of the pilgrims who travel through them submit their feedback through the HGO portal. It may be noted that the feedback received by the Ministry from the pilgrims will be taken into account while registering HGOs and allocating Haj quota to them in the future.

7. All HGOs must ensure that the details of the pilgrims, packages with cost, and agreements shall be uploaded on the HGO portal as per detailed instructions which shall be issued subsequently.
